



The public distribution system is one of the critical social support mechanisms of the government that reduces the incidence of hunger and malnourishment amongst the vulnerable sections of society. Social audits help in enhancing the effectiveness of the public distribution system, by enhancing awareness of the people of their basic rights under this programme and also by taking steps to ensure transparent functioning of the system.

The National Food Security Act of 2013 mandates that the functioning of the ration shops as well as the entire distribution system should be subject to social audits in order to ensure that the rights and entitlements of the people are protected. Social audits are conducted by agencies independent of the implementing agency. The Civil Supplies Department in an attempt to scale up the conduct of social audits across the state, has entrusted the Loyola College of Social Sciences with the conduct of social audit in 100 Fair Price Shops across the state. Social audits will be conducted through trained resource persons, students and NGO representatives. The department of Disaster Management will develop the social audit formats, conduct TOTs to train the resource persons, facilitate community mobilisation and organize the social audits. The social audit will take place in 100 different location spread across the state.

The total budget for the project is Rs 25,30,000.
