

Fr.Sabu P.Thomas, the Chairman of the Grievance Cell, convened the meeting welcomed all the members to the meeting. Besides the Hostel Wardens were instructed to ensure punctuality among the Hostellers.

#### Introduction

The meeting of the Grievance Redressal Cell was convened at 4pm on Friday 22 October 2021.

#### **Proceedings**

The Chairman of the Cell, welcomed the members to the meeting and read out the minutes of the previous meeting (21 January 2021). The matter arising acted upon were reported:

- 1. Regarding Aadhil K.U.'s complaint on 'inadequacy of Library Hours', the Academic Council had met and escalated the suggestions to the Staff Council
- 2. regarding the complaint regarding the preparation of fish-curry was conveyed and the Canteen Operator was advice to be sensitive about student preferences.

Fr. Sabu explained the special circumstances under which the meeting was convened. First was the long break due to the COVID. Secondly he had received a written complaint dated 7 September 2021, from a group of students, who were genuinely hurt apparently by the 'cutting down of the trees'. The Committee discussed the matter with due empathy and acknowledged the value of the issue raised by the students considering Loyola's commitment to nature, conservation of nature and our policy regarding environment. Fr.Sabu explained that some of the trees had outgrown and had reached a stage where the trees were precariously threatening loss to the building and other age-old structures. He cited a G.O. permitting cutting down of such trees that could damage the structure resulting in losses. The committee was empathetic to the students considering their genuineness; it considered the policy and the compulsions given the circumstance with threat to infrastructure and human life. The committee requested Fr.Sabu as a management representative to the College, to convene a meeting with the student community to explain the circumstances that lead to the cutting. The meeting was adjourned at 5.05 pm.
